#### 4. APPLICATION / LIMITATION

- 4.1 May be used for the following services on board:
- Ballast and bilge, sea water and fresh water, compressed air, domestic and sanitary systems.
- 4.2 The valves belong to Class II and Class III according to the relevant requirements stated in NR 467, Part C, Chapter 1, Sec 10 of the Bureau Veritas Rules.
- 4.3 The material is to be selected according to the nature of the fluid to be conveyed, taking into account the service conditions indicated in the manufacturer's catalogue for each type.
- 4.4 The use of ordinary cast iron and stainless steel is restricted as per BUREAU VERITAS rules.
- 4.5 The valves are not to be used where their deterioration, in case of fire, would risk to jeopardize the subdivision integrity or the safety of the ship.
- 4.6 The non-return valves are not to be used as shipside valves.

### **5. PRODUCTION SURVEY REQUIREMENTS**

- 5.1 The products are to be supplied by **SOCLA SAS** in compliance with the type and the requirements described in this certificate.
- 5.2 This type of product is within the category IBV of Bureau Veritas Rule Note NR320.
- 5.3 BV product certificate is required.
- 5.4 Bureau Veritas Certificates are required for materials of valve housings of Class II (DN≥100). Materials of valve housings of Class II (DN<100) and for other parts of Class II are to be provided with Work's certificates.
- 5.5 Each valve housing for Class II is to be hydraulically pressure tested to 1.5 times the design pressure.
